The Model 220-3000 (AirChek Essential), Model 220-3100, and Model 220-4000 (AirChek Connect) are portable air sampling pumps powered by battery pack part number P75718. The battery pack contains two rechargeable lithium-ion cells in series and is charged only in non-hazardous locations. The Model 220-3000 has a passive segmented LCD. Models 220-3100 and 220-4000 have a custom graphic LCD and may have Bluetooth capabilities and a backup lithium carbon monofluoride coin cell.

Temperature range

The ambient temperature range is -20°C to +45°C with a T4 temperature classification.
